

Once granted, you are entitled to a reduction of \$25,000 from the assessed value of your dwelling. To qualify you must be a permanent resident of Florida as of January 1, the year you apply for the exemption. Florida law does allow new homestead applications to be filed prior to January 1 of the year the exemption is to be effective. However, pre-filed applications will only be accepted after March 1 of each year for the succeeding year.


